- 3. Notice of Race of the SAYC's 2008 Annual Regatta

4. Organisation rules of SAYC's, if any

5. Payment of the entry fee of 50.000 EUR (details provided in the Notice of Entry)

 Signature of the representative of the Yacht club legalised and notarised with the Hague Apostille

 Signature of the representative of the Syndicate legalised and notarised with the Hague Apostille

 Confirmation of a notarised certificate stating that Mr. Tempesta is duly authorised to represent and commit SAYC's with his single signature
